The 1st DAB meeting of the AY 2022-23 was held on 23.07.2022 by 09.30 am at CABD Laboratory.


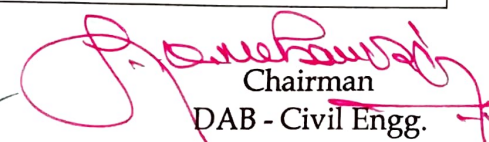
The Chairman of the DAB, Dr.E.K.Mohanraj, welcomed the members for the meeting. Then, the items listed below were taken for discussion.
