MEMORANDUM OF UNDERSTANDING BETWEEN
NANDHA ENGINEERING COLLEGE (AUTONOMOUS)
AND
KULOTHUNG AUTOMOTIVE SYSTEMS

PREAMBLE:

NANDHA ENGINEERING COLLEGE was established in 2001, presently, the Institution remains as a flagship brand of Nandha Educational Institutions with 7 Under Graduate & 9 Post Graduate programmes. It is recognized as one of the Best Engineering Colleges with State of the-art infrastructure and high quality technical education with the foresight and far reaching vision of our Illustrious Chairman Shri.V.Shanmugan. The college is in the forefront of Innovation in technical and management education.

The departments CSE, IT, EEE and ECE got accreditation by NBA and NACC, New Delhi. The Institution has got tie-up with Industries like Hexaware Technologies, Plymouth University,CTS and Infosys.

The college has membership with Professional societies like ISTE,CSI,IEEE and IE to bring more professionalism with course of their studies.

The department of Electrical and Electronics Engineering was established in the year 2002 with an intake of 60 and gradually it rose to the present strength of 120 with 20 faculty members. M/s. KULOTHUNG AUTOMOTIVE SYSTEMS having its office at 117, Mukasipadiyur,Chennimalai,Erode-638 051, Tamilnadu, India - and represented herein by its, **Director, Mr. S.NEHRU** (hereinafter referred to as “ASSOCIATE”)

AND

NANDHA ENGINEERING COLLEGE (AUTONOMOUS), having its Principal office at Erode - Perundurai Main Road, Vaikkaalmedu, Erode – 638052 TamilNadu, India and represented herein by its **Chairman Shri.V.Shanmugan** (hereinafter referred to as “INSTITUTION”)

WHEREAS:

- A) **ASSOCIATE** is the prime partner of INITIATIVE program as well as Recruitment and Training partner.
- B) The plan is to train the students, graduates and diplomas as per industry requirement and then we open the candidature for the internship to the industries. The industries can engage the students, graduates and diplomas on their projects who can be productive from day one.

- C) **INSTITUTION & ASSOCIATE** believe that collaboration and co-operation between themselves to promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 **ASSOCIATE** and **INSTITUTION** are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 **ASSOCIATE** and **INSTITUTION** co-operation will relate effective utilization of the intellectual capabilities of the faculty of **ASSOCIATE** providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry.
- 1.3 **ASSOCIATE** plans to commence Initiative programs at both party premises relying on the infrastructure facilities that the Initiative program needs.
- 1.4 The **INSTITUTION** shall provide the available infrastructure, workable space/room & basic amenities such as electricity, water, telephone etc., suitable and ready for delivering the training courses and other activities in conjunction with the **ASSOCIATE** in the scope
- 1.5 **INSTITUTION** may compulsorily impart 2nd and 3rd year students for internship training program and Industrial visit. The other initiative programs will be imparted time to time upon both parties discussion.

CLAUSE 2

SCOPE OF THE MOU

2.1 The budding graduates / engineers from the institutions could play a key role in technological up gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **ASSOCIATE** is going to conduct the following initiatives with the support of **INSTITUTION**

- Internship program
- One day workshop and Hands-on Training on core subject
- Entrepreneurial and Skill Development Workshop
- Industrial Visits
- Knowledge partner with industries
- Collaborative Research with Industry and Institution

CLAUSE 3

INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4

VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period INSTITUTION or ASSOCIATE, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of INSTITUTION or ASSOCIATE, after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 ASSOCIATE and INSTITUTION may terminate this MOU upon 180 calendar days' notice in writing. In the event of Termination both parties will have to discharge their obligations and INSTITUTION will make the full payment to the ASSOCIATE for the services provided.
