

ANNEXURE 2

GENERAL TERMS and CONDITIONS OF EMPLOYMENT

1. **Workplace** You are initially appointed to work in our office in Bangalore/online during your internship. Post which you will be stationed in our Bangalore office. You may be later transferred or required to travel to Coimbatore for Company's business/training at the discretion of the Company.
