## SERVICE LEVEL AGREEMENT

TERMS OF AGREEMENT GOVERNING INTERNET SERVICE CONNECTION THROUGH READYLINK INTERNET SERVICES LIMITED (HEREINAFTER REFERRED TO AS Readylink)

## **BANDWIDTH OR SERVICE CHARGES:**




### SERVICE DISCONTINUTION:
