



In Ref. 1 cited, Autonomous Status was extended to Nandha Engineering College, Erode, with certain conditions for a period of 'TWO' years from 09.02.2024. Representation was received from the college, requesting the University to reconsider the 'Conditional Autonomous Status', in-line with Clause 3.10 of UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations 2023. This matter was placed in 271st Syndicate Meeting, held on 29.07.2024. After careful consideration, the Syndicate resolved

- (i). To revoke the 'Conditional Autonomy' granted to Nandha Engineering College, with immediate effect.

- (ii). To extend the Autonomous Status for a period of 'TEN' years, as granted by UGC (Ref. 2) to Nandha Engineering College from the Academic Year 2023 – 2024 to 2032 – 2033.

In view of the above, it is informed that 'Autonomous Status' of Nandha Engineering College is extended for a period of 'TEN' years from the Academic Year 2023 – 2024. This college is required to abide by all the provisions of 'Statutes on Academic Matters 2023' of Anna University and Regulations, in force, from time-to-time.

3. Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ ST, Establishment of Internal Committee (IC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire and Safety Certificate should be maintained as per the provisions made in Approval Process Handbook and AICTE Regulation notified from time to time.
4. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
5. As per the AICTE Notification dated 29.01.2014 and amended thereto, it shall be mandatory for each Technical Education Institution, University Department and Institution Deemed to be University imparting Technical Education to get accreditation (NBA) for at least 60% of the eligible courses in the next ONE (1) Years' time, otherwise EoA for the subsequent Academic Year (A.Y. 2024-25) shall not be issued by the Council.


